Sub: Disclosure under Regulation 30 of the Securities and Exchange of Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Century Pulp & Paper, Lalkua, Dist. Nainital (Uttarakhand)

This has reference to our intimation dated 24th March, 2020 vide which it was informed to you that pursuant to Government of Uttarakhand's order dated 22nd March, 2020 the Company had achieved complete shutdown of its Pulp and Paper mill operations at Century Pulp & Paper, Lalkua, Dist. Nainital, (Uttarakhand) keeping in view pandemic Covid-19. Further to this vide our letter dated 3rd April, 2020, it was informed to you that District Magistrate, Nainital, Uttarakhand had vide its order dated 30th March, 2020 permitted the Company's aforesaid Division to operate its factory in a limited manner to cater to the requirements of essential services industries. Accordingly, the aforesaid Division had commenced operations and arrangement of logistics for its relevant plants with the help of 100 workers and it was also informed to you that Company had started operations at its cutting centres to cater to the packaging requirements of the Pharma Industries.

Now, this is to inform you that Nodal Officer (Corona) / Dy. Dist. Magistrate, Kosiakutoli (Nainital) has vide its order dated 15th April, 2020 permitted the aforesaid Division to operate its Board and Tissue Plants to manufacture packaging materials for medicines, sanitizers etc. and napkins




respectively required by the citizens of the country. Accordingly, this is to inform you that the aforesaid Division has started Tissue and Board production from the plants located at Century Pulp and Paper, Lalkua, Dist. Nainital (Uttarakhand) and three cutting centres are already in operation. Paper production is likely to start after the lockdown.
